SITE COORDINATOR- Coordinate, organize and supervise all aspects of the Volunteer Income Tax Assistance (VITA) program, which includes management of the VITA site during the tax filing season.

TAX PREPARER- Provide free tax return preparation for eligible taxpayers. Provide high quality service and uphold the highest ethical standards in order to establish and ensure the greatest degree of accuracy and public trust.

TAX SAVINGS SPECIALIST- Support Volunteer Tax Preparers by promoting options to clients to consider saving, financial education, and financial coaching.

GREETER- Screen all customers requesting tax assistance, identifying the type of return and tax schedules each customer will need assistance with, and ensuring they have all necessary information required to complete the return.

SCHEDULER- Assist in collecting data and making appointments for taxpayers accessing VITA services. Provide administrative support and technical assistance as required.
